

From the President

September 2020

Thanks so much for your support! As our unprecedented Donation Drive is drawing to a close I would like to thank all who have contributed so generously. At the time of writing (24 August) we have reached the magnificent total of \$9,300.00. A wonderful show of support for GSQ!! It's not too late to donate, if you haven't already done so. When conditions allow, we certainly intend conducting a big Thank You function. Once the Drive is concluded, those who have donated one of the larger amounts (\$500 and \$250) will be contacted to ascertain needs in relation to research to be undertaken on your behalf.

Do you have Irish Ancestry? Up to one third of Australians have. You may well be one of these and perhaps have experienced the frustrations that can accompany searching for Irish ancestors. GSQ is organising something which may help you in this regard – a virtual seminar (via Zoom) on Saturday 24 October (9.30am – 4.30pm) titled simply "Exploring Irish Ancestry". Speakers include our Patron, Dr Jennifer Harrison, Pauleen Cass, Cathie Sherwood and Helen V Smith from Australia and international speakers, John Grenham and Chris Paton. The presentations from our Australians will be live with Q & A at the end of their talks, while those from John Grenham and Chris Paton will be pre-recorded, BUT there will be a live Q & A with John and Chris at 5.30pm on the day of the seminar. An Early Bird Booking facility has been arranged with costs for this Seminar set at \$50 for Members and \$65 for Non-Members until 30 September. After this date the cost will be \$60 for members and \$75 for Non-Members. Attendance is capped at 100 - already 40 people have booked, so, if interested in attending, early booking is recommended. A Raffle is being organised in conjunction with the Seminar with tickets priced at \$2.00 each/5 for \$10.00. 



Strategies for Finding Female Ancestors

Throughout history, even the most enlightened societies often discounted women—leaving little "official" documentation of their lives and contributions. So take extra effort to uncover and discover more about your female ancestors with unconventional records, using the following tips:



Consider the whole lifetime. Much like your own, your female relative's life story was comprised of more than the major milestones. Don't stop at censuses and vital records. Think about her generation and its social history. What was happening locally, nationally and globally? What were the societal and cultural values of the time? This may point you to additional research options.

Think local. There's a good chance your ancestor was an active member of her community. From rural towns to bustling cities, women participated in local school events, church functions, war efforts and chapters of ladies-only societies. She may have even owned her own business or been part of a professional organization. Other, less-pleasant sources may include asylum or sanitarium records. All of these institutions and organizations kept records, many of which survive today.

Begin your search online (but don't stop there). Don't rely on digitized sources only. Many of these smaller records remain offline (in books, files and microfiche), and in the care of historical societies, libraries, and universities. With some persistence (and savvy Google skills), you can find where collections are archived. Then, contact the holding institution directly for more information and assistance.

From equality to social reform, our foremothers didn't give up—and neither should you!

What's in a Name? Tips for Finding An Elusive Ancestor

One of the things about genealogy is the fascinating variety of names and the many forms that one particular name can take. One memorable name that I encountered recently was Cadwallader Slaughter, often shortened to Cad Slaughter. What a name! It's a delicate science using names to determine the identity of one person, or distinguishing between many people. Here are the most significant things to remember about names in your genealogy research.

Tip #1: Pronunciation is More Important Than Spelling

Before the standardization of spelling in the twentieth century, people spelled names according to how they sounded. As long as a name was pronounced correctly, it often didn't matter which letters were used to spell it. The less common a name was, the more likely it was spelled in a variety of ways. A name could be spelled one way at the beginning, and another way at the end of the very same document.

Tip #2: Nicknames and Abbreviations Might Not Resemble Birth Names

A genealogist must be aware of common nicknames and abbreviations for common birth names in order to determine if they are dealing with the same person. Here are some related names that I often come across in my research:

Record Collections for England 1. General Register Office

Civil registration records for England and Wales can be found right here. Their archives date back to 1837 and include births, marriages and deaths. Start your search by locating the index from your record. Be sure to note that records were recorded quarterly and dates will be approximate – so be loose with date ranges when searching. Special features of the GRO are adoption records and the "Abandoned Children" and "Thomas Coram" registers.

2. The UK National Archives

With 195 family research guides available, the sky's the limit. The most popular guides include Census Records, the 1939 Register, and Wills from 1384-1858. Lesser known records include Insolvency, British Army Nurses, British Army War Diaries from 1914 to 1922, and Manorial Documents and Lordships. This site is so comprehensive and diverse, you may wish to set aside an entire day just to browse before committing yourself to specific research.

3. Free UK Genealogy

Free UK Genealogy is the umbrella organization that oversees FreeBMD, FreeREG and FreeCEN. It was developed as a Charitable Incorporated Organization with a belief in free public access databases and the organization has been actively transcribing documents for over 19 years. FreeBMD includes 270 million vital records like birth, marriage and death. FreeREG includes 43 million parish records, while FreeCEN focuses on census records from 1841 to 1891. This is such a remarkable resource for both England and Wales.

Collections for Northern Ireland 4. General Register Office of Northern Ireland

With vital records, of course! Those found within the GRO include civil births, marriages, and deaths. Northern Ireland is currently part of the UK, which requires you to distinguish where records might be held from varied historical times. Before 1921, records were generated by Ireland, with no further distinctions. Therefore, for records before this time, search within the Republic of Ireland. When in Belfast, do take the time to visit GRONI's (*General Register Office Northern Ireland*) Public Search Room.

5. Find My Past

Find My Past offers over two billion records from the UK, Canada and the US. It is a wonderful resource for census, church and immigration, newspapers and vital records. Imagine locating an image of your ancestor's baptism, written in Latin! You can find those records right here, many without a subscription. Some records unique to FMP include Workhouse and Poor Law Books, Poverty Relief Loans, Police Registers, and even Dog License Registers, which practically every farmer submitted.

6. National Library of Ireland

Griffith's Valuation is a key record collection that should be at the top of your list when conducting Irish genealogy research. It represents the first full-scale property tax assessment of Ireland residents, which was supervised by Sir Richard Griffith, a Dublin geologist. Extremely thorough, it included every parcel of land and its owners, not only in transcript form but also in detailed maps. Knowing the surname, county, barony, union and parish of your ancestor will be most helpful, but is not necessary.
